Deposits on wedding candida are not refundable if cancellation occurs within 180 days of the scheduled date of the wedding. Prices are subject to change without notice.

Our photographers have all been trained to take the very best pictures possible. In case of any mechanical or human error, however, Stuart-Rodgers cannot be held responsible. Our photographer will contact you the week of your wedding to confirm all details, times and arrangements. We would appreciate notification of any major changes before that time.

Orders placed 3 months after the release of the previews are subject to a 15% surcharge over our regular prices. After 6 months, you will be assessed a "photography charge" equal to your minimum order requirement and your deposit will apply only towards that photography charge plus any overtime due. All orders placed after six months will be billed in addition to the photography charges applied.

We ask that you check the sequence of your album prints before they are bound. If these prints remain un-checked by you for more than 6 weeks, Stuart-Rodgers will consider your order finished and the entire balance due and payable. Upon full payment of the account, you can either take delivery of the unbound prints or have them sent to our binder for finishing.

The undersigned party or parties, hereby gives Stuart-Rodgers permission to use the photographs herein contracted for, in any commercial advertisement or publication, for display, or for sample purposes.

Weather conditions, time restrictions, church restraints, lighting conditions and lack of subject co-operation are just some of the factors that make wedding photography an imperfect science. Please be assured that we are anxious to give you the best possible wedding photography, but good photography does not happen automatically. It will take your co-operation and teamwork to help us in this quest.

Since we know that you do not want to interfere with the success of your wedding photographer, *we ask that no friend or relative* takes pictures your Stuart-Rodgers photographer sets up. Please ask them to enjoy the wedding as a guest, not as another photographer. We reserve the right to cease our photographic services if any other person with a camera interferes with our photography of your event.
